Rental Terms and Conditions

1. If the RENTER is paying with credit card, he or she shall pay **\$5 per i^Clicker 2** to rent the unit for an academic semester. If the RENTER is paying with cash or check, the \$45 fee breaks down into a **\$5 non-refundable transaction fee** and a **\$40 refundable deposit**. Upon the device's return to the ASUC in good working condition, the ASUC, through the LEAD Center, shall fully reimburse the RENTER their deposit.
2. In the event the RENTER fails to provide proper payment (i.e. **bounced check**, misrepresenting finances) and the RENTER is unwilling to either to settle all outstanding financial debts or to return the device and pay any associated fees incurred by the ASUC, the ASUC reserves the right to file a case with UC Berkeley's Center for Student Conduct. Under this circumstance, the RENTER can be, and is not limited to being, charged with violating UC Berkeley's Student Code of Conduct clauses 102.04 (Theft) and 102.16 (Failure to Comply).
3. The RENTER shall keep and maintain the rented equipment during the terms of the rental at their cost and expense. The RENTER shall keep the equipment in a good state of repair.
4. The RENTER shall forfeit their right to the deposit in the event the device is lost, stolen, or is damaged and in need of repair to put it into the same condition it was in at the time of rental. Normal wear and tear is accepted.
5. The RENTER shall return the equipment to the ASUC at the RENTER's risk and expense.
6. No allowance will be made for any rented equipment claimed not to have been used.
7. The ASUC makes no warranty of any kind regarding the rented equipment, except that the ASUC shall replace the equipment with identical or similar equipment if the equipment fails to operate in accordance with the manufacturer's specifications and operation instructions. Such replacement shall be made as soon as practicable after RENTER returns the non-conforming equipment.
8. The RENTER shall pay all reasonable attorney and other fees, the expenses and costs incurred by the ASUC in protection its rights under this rental agreement and for any action taken ASUC to collect any amounts due to the ASUC under this rental agreement.
9. Acceptance of returned equipment by the ASUC does not constitute a waiver of any of the rights the ASUC has under the rental agreement.
